#### Honors and Recognition: AREA Receive Philanthropy Award

As our investors are keenly aware, the Albuquerque Regional Economic Alliance, formerly known as Albuquerque Economic Development, can trace its roots back to the 1960s.

In 2022, the organization transitioned from a 501(c)(6) to a 501(c)(3) to better execute on its mission to "grow and diversify the economic base of the greater Albuquerque region."

2022 was indeed a year of intentional evolution.

It included changing our longtime name from AED to AREA, rewriting our bylaws and articles of incorporation to shift to a missionbased focus for the organization, and for the first time ever creating a path for public/ private partnership with the inclusion of local government entities across greater Albuquerque.

We have also launched several new industry advisory councils designed to engage business leaders and inform and guide the implementation of our strategic plan.



In 2022 we also successfully completed a capital campaign to increase our annual operating budget while simultaneously decreasing dependency on its sustaining fund for day-to-day operations.

In the year ahead, one of AREA's main objectives is to concentrate on building the Albuquerque region's national brand and working on initiatives that ultimately make the region a better operating environment for businesses choosing to locate and grow in the region — creating and delivering jobs and opportunities for all.

We are tremendously grateful for the recognition received by Albuquerque Business First, and proud to be listed alongside the many other deserving nonprofits!

#### Making the Case for Downtown

More than 200 attendees joined us in March at the former Petroleum Club space on the 15th Floor of 500 Marquette Ave. NW in downtown Albuquerque, courtesy of ARGUS Investment Realty.

The program brought guest experts and local business leaders together for a positive conversation about the future vision of downtown Albuquerque. According to the International Downtown Association, great cities and regions start downtown and no great city or region can succeed without a strong downtown, the place where compactness and density bring people, capital and ideas into the kind of proximity that builds economies, opportunity and identity.

The event was headlined by guest speakers Amanda Elliott of the Town of Gilbert, Arizona and Brett Roler with the Downtown Memphis Commission. Following the guest speaker presentations centered around challenges and solutions implemented in each of their downtown communities, Charles Rath facilitated a fireside chat with several local leaders and visionaries who are excited and optimistic about the future of downtown: Terry Brunner, the Metropolitan Redevelopment Agency Director for the City of Albuquerque; Dale Armstrong, President and CEO of TLC Plumbing; and Mark Baker, owner of 505 Central Food Hall, Humble Coffee Co. and Moonwalk Brewery and Distillery.

Next steps in this conversation include a series of focus group discussions through June on business improvement district tools with property owners and community leaders in downtown. 
