


Statement

SEAMLESS PROJECT TRANSITION

The majority of owners and architects who work with EBC appreciate that we designate one person to be the Estimator, Project Manager, and Warranty Manager. The advantage to grouping the roles is to minimize hand-off from one person to the next, where intellectual knowledge is never 100% transfered. Instead, the person who sees the project from inception to completion carries with them 100% knowledge and understanding of the project. This allows a single point of contact to have a wealth of background information on every aspect of the project and every decision made during preconstruction. Therefore, there is no opportunity for discussions and past decisions made during preconstruction to be lost in translation from one individual to another.

CONSTRUCTION TECHNOLOGY

We use BIM to look out for potential collisions such as load bearing walls constraints, structural lintels, no-fly zones, future maintenance zones, head of wall conditions (where drywall must be installed at top of walls prior to MEP roughin due to future space constraints), boom lighting steel supports, lighting shadows, shelving spaces, future furniture installations, and many more. While building the project, we have the technology tools available to review BIM models while walking the jobsite to see what the final visual of a specific space is to be when it is complete. This helps us to gain a better understanding of the space. All BIM coordination drawings are followed during the installation. We make certain our subcontractors buy-in to this process for better collaboration.


IN-HOUSE DESIGN TECHNOLOGY


Enterprise Builders has the advantage of an in-house Registered Architect, BIM
